

**ORDINANCE No. 189482**

\* Authorize a three-year Intergovernmental Agreement with Portland State University in the amount of \$168,654 to implement Portland's Public Event Recycling Program 2019-2022 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Planning and Sustainability (BPS) needs to meet both the State of Oregon and the City of Portland's adopted waste reduction goals that rely on reducing garbage and increasing recycling and composting for all sectors – residential, multifamily and commercial.
2. Portland's Public Event Recycling Program provides essential information, resources and equipment to facilitate recycling, food scrap composting and waste prevention activities.
3. Portland State University (PSU) will support all the major, annually scheduled permitted events at Waterfront Park, Pioneer Square and the Park Blocks through technical assistance and vendor education and outreach. PSU also will support all interested community events by providing technical assistance, vendor education and outreach and recycling containers.
4. The established cost is \$168,654. Funds in the current year are available in the BPS Solid Waste Management Fund, FY 2018-19 budget, cost object 9PNSWC000003. Funds have been or will be requested for the remainder of the Agreement and included in the FY 2019-20, FY 2020-21 and FY 2021-22 Bureau of Planning and Sustainability budget.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute an intergovernmental agreement with PSU in a form substantially similar to the agreement attached as Exhibit 1, to this Ordinance for the purpose described in Section 1, in the amount of up to \$168,654.
- b. The BPS Director is authorized to negotiate and execute on behalf of the City any subsequent modifications to the agreement provided such modifications do not increase the City's financial obligation or risk.

Section 2.

The Council declares that an emergency exists because spring is the high season for public events and festivals and we want to ensure that event coordinators help the City meet its waste reduction and recycling goals. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


