ORDINANCE No. 189494

*Authorize a competitive solicitation and contract with the lowest responsible bidder and provide for payment for the Justice Center Elevator Modernization project for an estimated \$1,570,910 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. OMF-Facilities is responsible for modernizing four (4) elevators within the Multnomah County Justice Center that are located in the City's side of the building. The elevators were installed when the structure was constructed in 1982 and were modernized in 2006. After a recent assessment of their condition that the City commissioned by a third party, it was determined that the four (4) elevators need to be modernized to current code and functionality.
- 2. OMF-Facilities seeks Council's authorization for Procurement Services to issue a competitive solicitation and execute a contract for the Justice Center Elevator Modernization Project.
- 3. The engineer's estimate for this contract action is \$1,570,910.
- 4. The Bureau's confidence level in the estimated cost is optimal.
- 5. Funding of \$1,570,910 is available in the Facilities Services Fund in the FY 2018-19 and FY 2019-20 budgets.

NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer to facilitate the use of the competitive solicitation process in accordance with City Code for the purchase of services for the Justice Center Elevator Modernization project.
- b. Upon Council acceptance of the Chief Procurement Officer's Report recommending the contract award, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's Office.
- c. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Facilities Services Fund when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists to prevent delays in proceeding with the project. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
