Executive Summary - The architecture is moving along well and, on its way to becoming a very handsome building. Further refinement and coherency of elements detailed below should continue.

Summary of Comments:

East Façade

- The east façade is working well and has the appropriate amount and scale of glazing.
- The intersection of the lower bar at the tower is awkward. Explore ways to better integrate these two forms.
- A couple of Commission's struggled with the angled expression of the stair indicating it felt forced and out of character with the rest of the building. Continue to explore this element so that it feels more cohesive with the other elements.

Corner of SW 18th & Salmon

- The general concept with the glazed corner and saw-tooth are working well together.
- Explore removing the brick spandrel between the 1st & 2nd floors for a grander expression at the corner and so the ground level glazing is taller than the floors above, which is more typical.
- A Commissioner recommended exploring ways to "spice up" the corner expression so that it is a different vocabulary from the rest of the building, while retaining coherency.
- Similar to the east façade, the intersection of the lower mass at the tower needs work.
- The ground floor is working great, particularly with the active use of the library and extensive glazing and canopies.

West Facade

- The larger art panel is adequately sized to receive a meaningful art piece and appropriate for the terminus at this civic building.
- Reach out to PBOT to see if shifting the traffic signal fixtures in front of the art panel is possible.
- The stair at the south end is a successful way to terminate building.
- The varied façade adds interest on this very long façade.
- As indicated on the east elevation, the angled stair feels a little forced for some Commissioners.

<u>Ecoroof</u>

- All Commissioners were supportive of the ecoroof modification concept given the unique opportunity to provide a significant amount of on-site landscaping when none is required.
- Maintenance of the on-site landscaping to be counted as ecoroof was noted as being critical.

Materials

- The panels with the larger scale pattern seem more appropriate for the large mass of this building.
- Consider the panel texture options carefully as some are more prone to soiling.
- For the lighter colored panel, consider the tone and how it complements the red panel color.

<u>General</u>

- The rooftop elements and screening are very visible, particularly on the lower bar of the east elevation, and detract from the cohesiveness of the building. Explore how these can be minimized to not stand out.
- All Commissioners were supportive of the canopies locations, depth and angles as presented.
