

ORDINANCE NO. 130373

An Ordinance assigning names to certain park roads in the City of Portland park system, and declaring an emergency.

Section 1. The Council finds there appears to be an increasing need for assigning names to park roads in certain of the larger park areas so that the Police and Park Bureau may better identify locations, that to officially assign names to such roads is appropriate even though they will remain under full control and jurisdiction of the Bureau of Parks, and that such assignment of names is recommended by the Superintendent of Parks and the City Engineer; now therefore

1. That certain park road extending first northeasterly and then easterly from its intersection with N.W. Irving Street as established in Seblar, a recorded plat, to its connection with N.W. Monte Vista Terrace at the west line of Kings Heights, a recorded plat, shall hereafter be known and designated as N.W. Pittock Drive.

2. That certain park road extending first northerly, then southerly and then westerly from its intersection with West Burnside Street at a point immediately south of the north line of Section 5, T.1S., R.1E., W.M., to its intersection with S.W. Fairview Boulevard at a point approximately 1000 feet southerly of the intersection of said S.W. Fairview Boulevard with the west line of Arlington Heights, a recorded plat, shall hereafter be known and designated as S.W. Fairview Way.

3. That certain park road extending first southeasterly and then easterly from its intersection with S.W. Cascade Drive at a point approximately 100 feet south of the south line of Arlington Heights, a recorded plat, to its intersection with the west line of Hoyt, a recorded plat, shall hereafter be known and designated as S.W. Upper Cascade Drive.

4. That certain park road extending southerly from its intersection with S.W. Fairview Boulevard at a point approximately 600 feet east of the east line of Highlands Plat No. 2, a recorded plat, to its intersection with S.W. Canyon Road near the Portland Zoological Gardens shall hereafter be known and designated as S.W. Knight's Boulevard.

5. That certain park road extending first southerly and then westerly from its intersection with S.W. Kingston Street near the Japanese Gardens, to its intersection with S.W. Knight's Boulevard, hereinabove named, shall hereafter be known and designated as S.W. Kingston Drive.

6. That certain park road extending first easterly, then northerly and then easterly from S.E. 60th Avenue at S.E. Lincoln Street, to its connection with S.E. Harrison Street at the east line of Mount Tabor Park, shall hereafter be known and designated as S.E. Lincoln Drive.

7. That certain park road extending southerly from its intersection with S.E. 69th Avenue at the south line of Tabor Heights, a recorded plat, to its intersection with S.E. Lincoln Drive, hereinabove named, at a point approximately 800 feet west of the east line of Mount Tabor Park, shall hereafter be known and designated as East Tabor Drive.

8. That certain park road extending westerly from its intersection with East Tabor Drive, hereinabove named, at S.E. 69th Avenue, and terminating approximately 400 feet westerly of S.E. 66th Avenue, if extended southerly, shall hereafter be known and designated as S.E. Taylor Street.

9. That certain park road extending first southeasterly and then northerly from S.E. Salmon Street at S.E. 63rd Avenue, to its intersection with the westerly terminus of S.E. Taylor Street, hereinabove named shall hereafter be known and designated as Salmon Street Way.

10. That certain park road extending first easterly, then southerly and then northwesterly from its intersection with S.E. Taylor Street at Salmon Street Way, both hereinabove named, to its intersection with Salmon Street Way near the south line of the Nelson D. L. C., shall hereafter be known and designated as Reservoir Loop Drive.

11. That certain park road extending southeasterly from its intersection with Reservoir Loop Drive, hereinabove named, near S.E. 68th Avenue if extended southerly, to its intersection with East Tabor Drive, hereinabove named, near the north line of the D. D. Prettyman D.L.C., shall hereafter be known and designated as North Tabor Drive.

12. That certain park road extending southerly from its intersection with Reservoir Loop Drive at North Tabor Drive, both hereinabove named, and forming a loop around the summit of Mount Tabor, shall hereafter be known and designated as Tabor Summit Drive.

ORDINANCE No.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That there should be no unreasonable delay in naming certain roadways in the City of Portland Parks, therefore, an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage by the Council.




