

## ORDINANCE No. 189505

Authorize the Director of the Bureau of Environmental Services to formally adopt a jointly developed Trail Master Plan for the Tryon Creek State Natural Area to the Willamette River Greenway, and to work in partnership with the City of Lake Oswego and Metro on the implementation of the plan (Ordinance)

The City of Portland ordains:

### Section 1. The Council finds:

1. On December 22, 2004, The City of Portland granted a permanent, exclusive easement to the City of Lake Oswego over and across a tract of land shown on the attached Exhibit 1. The purpose of the easement is for public park, recreation and open space uses, including the construction, repair, replacement and maintenance of improvements and landscaping relating to such uses. Usage will be of a passive recreational nature where the main function will be to provide Greenway riverfront enjoyment and circulation from the southern park area (Foothills Park) owned by the City of Lake Oswego to Tryon Creek and the City of Lake Oswego's property to the north.
2. On February 18, 2010, City Council approved an IGA with the City of Lake Oswego for Phase II of the Tryon Creek Confluence Habitat Enhancement Project. The Bureau of Environmental Services (BES) constructed this habitat enhancement project in an area that includes property owned by Lake Oswego at the confluence of Tryon Creek and the Willamette River. Lake Oswego allowed BES to construct this project under certain conditions, including allowances for a future pedestrian bridge and path alignment through the project area. The intent of both parties is to work cooperatively to achieve the public benefits that will result from improving habitat for native fish species in the Tryon Creek confluence area, and from improving pedestrian trail connectivity in Lake Oswego and throughout the region.
3. On May 30, 2018, City Council passed Ordinance No. 188980, authorizing BES to enter into an IGA with the City of Lake Oswego and Metro to collaborate on the development of a Tryon Creek Cove Trail Master Plan. The Trail Master Plan provides a recommendation for a new regional trail alignment and pedestrian bridge crossing from Tryon Creek State Natural Area (Oregon State Parks) on the westside of Highway 43/State Street at SW Terwilliger Boulevard, to the existing trail in Foothills Park. Until the trail and bridge are built, BES, City of Lake Oswego, and Metro will manage, maintain, secure, and operate the Tryon Creek Cove Park area in partnership as it is currently being carried out.
4. In March 2019, the Tryon Creek Cove Trail Master Plan was finalized, and on April 16, 2019 the Plan was formally adopted by the Lake Oswego City Council

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services, or the Director's designee, is authorized to formally adopt the Tryon Creek Cove Trail Master Plan.


