

# ORDINANCE No. 189514

Amend regulations for Tree Planting & Preservation Fund to improve tree planting program outcomes (Ordinance; amend Code Section 11.10.070 and Chapter 11.15)

The City of Portland Ordains:

Section 1. The Council finds:

1. Ordinance No. 184522, effective as of January 1, 2015, authorized establishment of the Tree Planting and Preservation Fund.
2. Expanding the urban forest and the benefits it provides to all community members is a primary goal of the Urban Forest Management Plan and Title 11 Trees.
3. Portland Parks & Recreation has proposed an update to City Code Chapters 11.10 and 11.15 to respond to City Auditor recommendations and improve tree planting program outcomes.

NOW, THEREFORE, the Council directs:


- a. Portland City Code Section 11.10.070 Fees and Chapter 11.15 Funds and Contributions is amended as shown in Exhibit A.
