

ORDINANCE No. 189543

*Accept a \$13,460 grant from Metro and authorize Intergovernmental Agreement for South Waterfront Wayfinding enhancement (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Metro, the regional government for the Portland metropolitan area, conducts a Regional Travel Options grant program to support safe, vibrant and livable communities through increased transit, walking, bicycling, carpooling, and telecommuting access and resources.
2. Through a competitive grant process, Metro selected a grant application for \$13,459.50 from the nonprofit South Waterfront Community Relations to increase bicycle wayfinding in the South Waterfront District.
3. Given that the Portland Bureau of Transportation (PBOT) already plans and installs bicycle wayfinding, South Waterfront Community Relations and Metro agreed that granting the funds directly to PBOT would reduce project costs and maximize the impact of grant funds.
4. PBOT consulted Metro and South Waterfront Community Relations to identify eight additional bicycle wayfinding locations within and to the South Waterfront District.
5. Metro and its RTO program is the recipient of Federal Transit Administration, Congestion Mitigation and Air Quality and Surface Transportation Program funds, and wishes to enter into this Agreement with PBOT.
6. Metro has allocated \$13,459.50 of RTO funds toward this agreement; and
7. PBOT has committed to match 10.27 percent or \$1,540.50, making the total project cost \$15,000.

NOW, THEREFORE, the Council directs:


- a. The Commissioner-in-Charge is hereby authorized to accept on behalf of the City of Portland a grant from Metro for the South Waterfront bicycle wayfinding enhancement in the amount of \$13,459.50. Any increases to the Grant Amount must be approved by the City Council.
- b. The Commissioner-in-Charge to execute a Metro Grant Agreement #935878 in the amount of \$13,459.50 in a form similar to the contract attached as Exhibit A.
- c. The Commissioner-in-Charge is authorized to execute amendments, approved

as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk.

- d. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Commissioner-in-Charge's behalf.

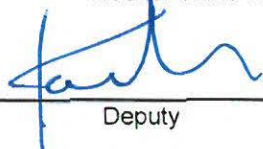
