

Harvey McGowan Bio:

Harvey McGowan served for thirty years as a City of Portland employee before retiring in 2002. Among his positions with the City were Human Resources Manager for the Bureau of Environmental Services, Public Safety Site Team Manager for the Bureau of Human Resources, and Civil Service Board Secretary for the Bureau of Personnel Services/Civil Service Board.

During and after his tenure with the City, Mr. McGowan has been an adjunct faculty member of Portland Community College teaching HR Management courses.

Mr. McGowan earned a Bachelor's degree in Psychology from the University of Portland and a Master's degree in Industrial Psychology from Portland State University.

In making appointments to the Board, the HR Director has tried to reflect the perspectives of labor, management, and the general public. Mr. McGowan will represent the perspective of the general public through his background in Human Resources. Mr. McGowan is an excellent candidate, committed to the principles underlying Chapter 4 of the City Charter. He is also a resident of the City, a Charter requirement.

Richard Schwarz bio:

Mr. Schwarz served four decades in the labor movement and 24 years as executive director of American Federation of Teachers (AFT) Oregon. Mr. Schwarz was AFT-Oregon's first executive director. Mr. Schwarz retired in February 2013 but continues to participate in volunteer public roles. He twice served as President (2002-03, 1994-95) of the Oregon Chapter of Labor and Employment Relations Association (formerly Oregon Industrial Relations Research Association). He is a former reporter with a philosophy degree and a journalism degree from the University of Wisconsin Madison.

In making appointments to the Board, we have always tried to reflect the perspectives of labor, management and the general public. Mr. Schwarz will continue to reflect the perspective of labor. Mr. Schwarz is an excellent candidate, committed to public service and to the principles underlying Chapter 4 of the City Charter. Mr. Schwarz is also a resident of the City, a Charter requirement. He has served as a Commissioner since November 2014. Thank you for your consideration of this candidate.
