

ORDINANCE No. 189564

* Pay settlement of employment lawsuit of Dylana Lewis in the sum of \$20,000 involving the Portland Water Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Dylana Lewis, through attorney Micah Fargey, has filed a lawsuit against the City for damages related to her employment with the Portland Water Bureau.
2. The lawsuit has been investigated by Risk Management. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
3. Risk Management and the City Attorney's Office recommend that Lewis's lawsuit be compromised for the total sum of \$20,000, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.


NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$20,000 made payable to Dylana Lewis and Fargey Law PC.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling the claims of this plaintiff; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


