Re: Recommendation for Reassignment, Reappointment and Appointment to the

Portland Design Commission

The Portland Design Commission has three upcoming changes that needs action. The Portland Design Commission provides leadership and expertise on urban design and architecture and on maintaining and enhancing Portland's historical and architectural heritage. The Portland Design Commission hears Type 3 Land use applications and Type II appeals of proposals within design districts.

Reassignment - Developer

I am recommending that Garry "Don" Vallaster be reassigned from the "Architect" position to the "Developer" position on the Design Commission. This reassignment, to be effective July 1, 2019, will fill the "Developer" position which was vacated by Andrew Clarke on May 22, 2019. Don's current "Architect" position will then be filled by Appointment, recommended below. Don is an experienced land developer and has over 30 years' experience with all elements of building construction and development.

Reappointment 2nd Term – Developer

I am recommending that Commissioner Don Vallaster be reappointed to a second term, August 15, 2019 – August 14, 2023. Don's continuation on a second term with the Design Commission comes at critical time given his expertise in the Land Use process, and in construction and material technologies. Don is experienced with the Land Use process, and over the past couple years have aligned very quickly with the direction of the Commission, and concerns of neighbors, yielding high quality urban design proposals, often needing only one hearing to be approved. This type of "leadership by example" is a helpful perspective to maintain on the Design Commission and impress upon future customers of the Land Use process to work with the Commission to complete projects faster and better, minimizing the number of hearings, while yielding high quality compatible designs.

Appointment - Architect

Lam recommending Chandra Robinson to serve her first term on the Portland Design Commission. Chandra is a unique candidate for the Design Commission by virtue of her global architectural experience, and native roots and architectural practice here in Portland. Chandra worked with Architects Without Borders for nearly 10 years, assisting communities in need in Tanzania, Haiti and Nepal by providing design and planning services through listening and collaborating with many cultures. In Portland, while working for a local architectural firm, she collaborated on a community charrette for Right 2 Root, working with members of the Emanuel Temple to help envision what is missing in their community and what to add in order to bring the community together. Chandra has practiced with many architectural firms, directly designing and managing various scales of development and has demonstrated a strong knowledge of local codes and design review processes. These professional and personal experiences, both at home and abroad, make Chandra an exceptional candidate for the Portland Design Commission, adding a strong voice with a diverse background of architectural and cultural experiences.

Chandra's first term would be from July 1, 2019 through June 30, 2023.

Chandra's appointment will continue to ensure the Portland Design Commission's high bar for leadership and expertise on urban design and architecture and maintaining and enhancing Portland's architectural heritage.

Recommendation

Reassign Garry "Don" Vallaster from the "Architect" position to the "Developer" position on the Design Commission effective July 1, 2019 through the end of Don's 1st term on August 14, 2019...

Reappoint Garry "Don" Vallaster to the Developer position on the Portland Design Commission a second term from August 15, 2019, through August 14, 2023.

Appoint Chandra Robinson to the Architect position on the Portland Design Commission for her first term from July 1, 2019 through June 30, 2023.
