ORDINANCE No. 189589

*Authorize a participating agreement with Municipal Emergency Services, Inc., for Self-Contained Breathing Apparatus in the amount of \$3.5 million (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

- Portland Fire and Rescue (PF&R) is responsible for the operation and maintenance of self-contained breathing apparatus (SCBA). PF&R last purchased full sets of selfcontained breathing apparatus in 2002 and have upgraded several parts of the equipment to remain in compliance with the National Fire Protection Association (NFPA) and National Institute of Occupational Safety and Health (NIOSH) standards. It is no longer a viable option to upgrade pieces of the equipment to meet current standards.
- 2. PF&R's SCBA Technical Committee performed an extensive testing and evaluation process to determine which make and model of SCBA would best meet PF&R's technical specifications and key performance criteria, as well as NFPA Standards.
- 3. The necessary SCBA equipment is available through a cooperative agreement sponsored by National Purchasing Partners (NPP.gov) with Municipal Emergency Services, Inc, that resulted from an open, competitive solicitation performed in line with State of Oregon and City of Portland procurement requirements.
- 4. The total cost of the equipment to be purchased is estimated to be \$3,500,000.
- \$2,053,728 of this project will be paid for by the 2017 Assistance to Firefighters Grant (AFG), awarded by the Federal Emergency Management Agency (FEMA) to PF&R. Approximately \$1,445,332 will be paid for by the General Fund from PF&R's FY 2019-2020 equipment replacement budget appropriations.
- 6. The Bureau's level of confidence in the cost estimate is high as the cooperative agreement has established pricing.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute a participating agreement with Municipal Energy Services, Inc. in a form to be reviewed and approved as to form by the City Attorney's Office prior to execution.
- b. The Mayor and City Auditor are authorized to draw and deliver checks chargeable to Fund 217001 and Fund 100000 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because a delay would prevent the City from completing the required grant activities within the grant deadline of September 6, 2019; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


