

ORDINANCE No. 189595

*Authorize ten grant agreements and Intergovernmental Agreements related to the Community Watershed Stewardship Program for \$100,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland City Council adopted the Clean River Program on April 6, 1990. In 1995, the Bureau of Environmental Services developed the Community Watershed Stewardship Program (CWSP) to provide grant funds and technical assistance for citizen led watershed projects. On March 8, 2006, the Council adopted the 2005 Portland Watershed Management Plan which describes actions for watershed health including citizen led activities such as natural area revegetation, education, involvement and stewardship. On May 2, 2012, Council adopted resolution #36920, reaffirming the City's commitment to watershed health.
2. These grants have been selected for FY19-20: Lower Columbia Estuary Partnership's Sitton Schoolyard Stormwater Project (\$11,997), Columbia Slough Watershed Council's Wapato on the Slough (\$8,684), Wisdom of the Elders' Columbia Slough Water Trail Guide and Restoration (\$10,740), The Blueprint Foundation's Constructing Careers Green Building Mentoring Program at Dharma Rain Zen Center (\$12,000), Depave's Centennial School District Depave at Powell Butte Elementary (\$12,000), Division Midway Alliance's Cleanup & Youth Engagement Through Environmental Education (\$10,050), Johnson Creek Watershed Council's 22nd Annual Watershed Wide Event (\$7,145), Urban Greenspaces Institute's PSU and Siletz Indigenous Garden (\$9,640), Tryon Creek Watershed Council's Mobile Training Program (\$9,000), and Leach Garden Friends' Community Restoration Project (\$7,000). Additional community projects will be awarded Native Plant Certificates, not exceeding \$500 each, for the purchase of native plants for stormwater and natural area restoration projects (\$1,744). Funds unspent by grantees will be used to purchase additional Native Plant Certificates, not-to-exceed program area total of \$100,000.
3. The established cost is \$100,000. Funds are available in the Sewer System Operating Fund, FY 19-20 Budget, Bureau of Environmental Services, Cost Center ESWS000007, 529000 (\$100,000).

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to execute grant agreements and IGAs for the purpose described in Section 1, in an amount not to exceed \$100,000 for FY19-20.
- b. All agreements authorized by this ordinance are subject to approval as to form by the City Attorney's Office.

- c. The Mayor and Auditor are hereby authorized to pay for the agreements from the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.

Section 2.

The Council declares that an emergency exists because it is necessary to award agreements without delay to begin Community Watershed Stewardship projects during the summer months; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.




