

PORTLAND YOUTH CLIMATE COUNCIL

We believe that in order to better protect Portland's urban environment, and address the goals of Portland's 100 Percent Renewable Energy Resolution, the City of Portland should do the following:

- **Remove from the Tree Code the December 31, 2019 sunset clause that would do away with protections for large trees**
 - Doing this would reduce urban heat islands
 - Protect habitat for wildlife in the city
 - Allow for further carbon sequestration, and stop the release of large amounts of stored carbon
 - Help maintain irreplaceable natural treasures

- **Remove from the Tree Code commercial and industrial zoning exemptions**
 - Past arguments for exemptions are no longer relevant, as quotas for land have already been met according to the Economic Opportunities Analysis
 - Would force accountability for everyone who wants to take part in Portland's economy, and ensure that corporations don't get environmental breaks
 - Would prevent the loss of trees and natural habitat in Portland, like we are likely to see at Wapato


