## **ORDINANCE No.** 189613

Amend Portland Policy Documents Code to update and clarify repository procedures (Ordinance; amend Code Chapter 1.07)

The City of Portland ordains:

Section 1. The Council finds:

- City Code Chapter 1.07 establishes procedure by which the City's formally adopted policies and administrative rules are collected and maintained in the Portland Policy Documents repository, in a format that provides easy access for the public.
- 2. Various provisions in Chapter 1.07 should be updated, including to more clearly describe the types of documents that are included in the Portland Policy Documents repository, remove gender-specific and outdated language, eliminate requirements for filing paper copies of documents, and reference the City Auditor's rule-making authority established through the 2017 amendments to the City Charter.

NOW, THEREFORE, the Council directs:

a. Code Chapter 1.07 is amended as shown in Exhibit A.
