* Authorize disposal of surplus shields property and authorize the Portland Police Bureau to proceed with donation of the property (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Police Bureau has and wishes to donate 34 Patriot, 3 Minuteman, and two folding shields. These shields are no longer required by the Bureau's Operations Branch and have been identified as being usable surplus.
- 2. The shields have expired ballistic panels and have been replaced by a lighter, easier to deploy shield.
- 3. An Ordinance is required by City Code Section 5.36 for the donation of surplus property.

NOW, THEREFORE, the Council directs:

a. That the donation of 34 Patriot, 3 Minuteman, and two folding shields is authorized upon the execution of hold harmless with the recipients as outlined in a form similar to the hold harmless agreement template attached as Exhibit A.

Section 2. The Council declares that an emergency exists as it is important for the benefit of the City to effect a complete removal of the surplus property and to determine the final disposition without additional delay; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


