These appointments and reappointments will fill five of the six positions on the River Community Advisory Committee (RCAC) as required by Portland City Code Title 28.03.015.

The River Community Advisory Committee is a citizen advisory body, composed of six members who represent a variety of floating structures interests. Members are appointed by the Mayor and confirmed by the City Council for three-year terms and will serve no more than two complete three-year terms, unless the Director recommends approval of a longer term and the Mayor and City Council approve the extended appointment, as specified in Portland City Code Title 28.

I am recommending appointing three new members to the RCAC for 3-year terms from August 7, 2019 through August 6, 2022 – Dan Carlson, Tom Lisch, and Bryrick Shillam. All three will be filling vacation positions on the committee and have a variety of experience working and living in the river community.

I am also recommending reappointing Karla Divine and Jesse Fox to the RCAC for second, 3-year terms from October 7, 2018 through October 6, 2021. Both Karla and Jesse have enjoyed serving on the RCAC and are looking forward to continuing a 2nd term. Both candidates have extensive experience working and living in the river community.
