

## ORDINANCE No. 104465

An Ordinance authorizing and directing the Purchasing Agent to advertise for and receive proposals for furnishing materials and labor to re-roof a portion of the University Park Community Building, authorizing a contract therefor, and declaring an emergency


The City of Portland does ordain as follows:

Section 1. That the Purchasing Agent be and he hereby is authorized and directed to advertise for and receive proposals for furnishing the materials and labor to re-roof a portion of the University Park Community Building, for the Bureau of Parks, in accordance with the plans and specifications therefor filed in the Bureau of Purchases and which are hereby adopted.


Section 2. That the Mayor and Commissioner of Finance be and they hereby are authorized to enter into a contract with the lowest responsible bidder for furnishing materials and labor to re-roof a portion of the University Park Community Building; provided, however, that in case no bids are received which are satisfactory to the Council, the Purchasing Agent be and he hereby is authorized and directed to readvertise therefor such number of times as may be necessary to receive acceptable bids; that the Mayor and Auditor be and they hereby are authorized to draw warrants on the appropriation Park Maintenance, General Fund (1840.420) when demands therefor are presented approved by the proper authority.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that the building may be reroofed before the beginning of the rainy season; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
