TO THE COUNCIL:

The Council adopted Ordinance No. 188310 on April 5, 2017 that authorized a competitive solicitation per City Code 5.34.880 for an Energy Savings Performance Contract (ESPC) for existing buildings and structures owned and managed by Portland Parks & Recreation. The selected Energy Service Company (ESCO) is responsible for designing, installing, commissioning and monitoring the improvements using a team of consultants and subcontractors.

A Request for Proposals for the Portland Parks & Recreation Energy Savings Performance Savings Contract, RFP No. 00000717, was issued on August 17, 2017. Four (4) proposals were received, reviewed, evaluated, and scored by a five (5)member evaluation committee including one (1) member of the Minority Evaluator Program in accordance with Portland City Code 5.34. The evaluation committee selected McKinstry Essention, LLC as the highest scoring proposer. A professional services contract was awarded on January 1, 2018 which required a Preliminary Utility Audit, a Technical Energy Audit, and a Project Development Plan which has been completed.

The Chief Procurement Officer recommends the award of a design build contract to McKinstry Essention, LLC for the design and construction of the Portland Parks & Recreation Energy Savings Performance Contract for the Guaranteed Maximum Price of \$998,998.

The City has established an aspirational goal for State of Oregon COBID certified Disadvantaged, Minority, and Women owned firms as well as Emerging Small Businesses (D/M/W/ESB) in subcontractor and supplier utilization at 20% of the hard construction costs for the project. McKinstry Essention, LLC made a commitment in their proposal of 20% utilization of COBID D/M/WBE certified subcontractors, material suppliers and manufacturers on this project.

McKinstry Essention, LLC anticipates awarding a subcontract total of \$585,486, and of that subcontract total, it is estimated that \$322,017.30 will be awarded in the following scopes of work to D/M/WBE certified subcontractors, which is 55% of the subcontract total.

McKinstry Essention, LLC is located in Portland, Oregon, and is not a State Certified D/M/W/ESB Contractor. They have a current City of Portland Business Tax Registration and EEO Certification, and are in Full Compliance with the City's contracting requirements.

Funds are available for this project under Owner Cost Center PKSB000013.

It is recommended that a Performance Bond and Payment Bond each at 100% of the contract amount be furnished by the Contractor. Further, it is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
