

# ORDINANCE No. 104485

An Ordinance authorizing and directing leaves of absence with pay for Joseph F. Gray and James Backenstos, Electrical Division, for the purpose of attending the 1956 Annual Meeting of the Northwestern Section, International Association of Electrical Inspectors at Salt Lake City, Utah, September 10-12, 1956; authorizing certain expenses; authorizing the drawing of warrants; making a transfer of funds; and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that the 1956 Annual Meeting of the Northwestern Section, International Association of Electrical Inspectors will be held at Salt Lake City, Utah on September 10, 11 and 12, 1956 and that it is in the interest of the city that Joseph F. Gray and James Backenstos of the Electrical Division should attend the said meeting and that the expenses for James Backenstos will be paid by the local chapter of the International Association of Electrical Inspectors but that the City of Portland should pay the expenses for the said Joseph F. Gray; now, therefore, leaves of absence with pay are hereby granted to Joseph F. Gray and James Backenstos for the period from September 10, 1956 to September 12, 1956, both dates inclusive, and such additional time as may be necessary in traveling to and from the said meeting, and the Mayor and Auditor are hereby authorized to draw and deliver to Joseph F. Gray a warrant in the sum of \$125.65 chargeable to the appropriation Electrical Division Operation and Maintenance, Code No. 2840.310, to cover the necessary expenses in connection with the trip herein authorized provided that upon returning to the city the said employee shall file with the Auditor a certified statement of his expenses together with such vouchers and receipts as may be available and the said employee shall return to the city the remainder, if any, of the funds provided.

Section 2. The sum of \$125.65 is hereby transferred from the General Fund Appropriation, Emergencies and Unforeseen Expenditures, Code No. 4100, to the appropriation, Electrical Division Operation and Maintenance, Code No. 2840.310.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that the required leaves of absence and traveling expenses may be authorized without undue delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
