

ORDINANCE No. 189693

*Change the salary grades of the nonrepresented classifications of Accounting Supervisor, Surveying Supervisor, Emergency Communications Systems Administrator, Surveying Manager, City Forester, and Deputy Director I. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary grades of the Accounting Supervisor, the Surveying Supervisor, the Emergency Communications Systems Administrator, the Surveying Manager, the City Forester, and the Deputy Director I classifications, effective December 13, 2018.


NOW, THEREFORE, the Council directs:

- a. The following compensation rates are being changed, effective December 13, 2018:
