#### Appointee bio

Taylor Smiley Wolfe is the Director of Policy and Planning for <u>Home Forward</u>, a mission driven organization that develops and operates affordable housing. She manages policy analysis processes, supports long-term planning, and helps the organization leverage its role to improve collaboration and efficacy between systems impacting people in poverty. Prior to joining Home Forward, Taylor was the Policy Director for Oregon House Speaker Tina Kotek. Taylor has also served as a policy analyst and researcher for PolicyLink, Former Secretary of Labor Robert Reich, and the Dellums Institute for Social Justice. Taylor has a Master of Public Policy (M.P.P) from the Goldman School of Public Policy at UC Berkeley.

## Appointee Statement of Interest

I am excited by the possibility of leveraging my skills in evidence-based policy making to advise a group of elected and appointed leaders who are committed to addressing the affordable housing crisis in a way that influences policymaking across the country. When I moved back to Portland in 2016 after living in Oakland and working to address the affordable housing and displacement crisis in the Bay Area, I was and continue to be inspired by the innovative and bold solutions being considered and passed into law in Portland.
