

ORDINANCE No. 189708

*Authorize contract with lowest responsible bidder for SE 136th Paving: Foster to Division Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. SE 136th is the largest paving project in the Fixing Our Street program.
2. PBOT is using System Development Charge funding to provide protected bike lanes and sidewalks along the entire corridor.
3. This project will install new streetlights, 48 new or upgraded ADA curb ramps, and plant over 40 trees.
4. The Bureau of Transportation has funds budgeted in FY 2019 and proposed FY 2020 for construction, inspection and management of the project.
5. The Bureau's level of confidence in the cost estimate for this project is high. The project is at 95% design and will go to procurement this fall.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to facilitate the competitive solicitation process in accordance with City Code 5.33 to obtain the lowest most responsible bidder.
- b. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to award, negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's Office.
- c. The Auditor to draw and deliver warrants chargeable to T00589 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because delay would result in street improvements not being delivered to residents in a timely fashion therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


