

ORDINANCE No. 189717

*Authorize an Intergovernmental Agreement with Portland State University to conduct disability engagement and equity research not to exceed \$75,000 (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

1. The local data on people with disabilities is either nonexistent, outdated, or not disaggregated.
2. The Office of Community & Civic Life is adopting more rigorous data-informed approaches to program design and all aspects of their work.
3. To better serve Portland's diverse disability communities, data on local disability communities must be collected. To contribute to our efforts, there must be an emphasis on indicators of equity and community & civic engagement, disaggregated by race/ethnicity, gender, language, etc.
4. This IGA will fund research increasing the data available to the City of Portland on the disability community in general. It will provide information on how people with specific disabilities are served by and engage with the City. Because the data will be able to be disaggregated, it will also inform additional aspects of our City's equity work, leading with racial equity.
5. Civic Life will use this research, along with data from and in partnership with other city bureaus, to inform efforts to ensure community members with disabilities are receiving equitable services.
6. The City desires to contract with PSU, which has the capacity to perform community-based research concerning civic engagement, and who will subcontract with a community-based organization for deeper reach into diverse disability communities.
7. ORS 190.010 to 190.030 authorizes units of local government in the state of Oregon to enter into written agreements with any other unit or units of local government for the performance of any or all functions and activities that any of them has the authority to perform.

NOW, THEREFORE, the Council directs:


- a. The Director of the Office of Community & Civic Life is authorized to execute an intergovernmental agreement with Portland State University in an amount not to exceed \$75,000 and in a form substantially similar to Exhibit A.

- b. The Director of the Office of Community & Civic Life of the City of Portland is authorized to execute an amendment to this Agreement provided such changes do not increase the City's financial obligation.
- c. The Director is authorized to amend the not-to-exceed value of the grant to provide additional funding if the funding for the amendment is expressly allocated by City Council in the City's adopted budget.

Section 2. The Council declares that an emergency exists because time is of the essence. Project work must begin as soon as possible for agreed upon deliverable and fiscal deadlines to be met. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


