

# ORDINANCE No. 189727

Extend subrecipient contract with Metropolitan Public Defenders by \$100,000 in Recreational Cannabis Tax funding to support the expungement pilot program to June 30, 2020 (Ordinance; amend Contract No. 32001866)

City of Portland ordains:

Section 1. The Council finds:


1. The Housing Bureau's Rental Services Office was allocated \$100,000 in Recreational Cannabis Tax resources in fiscal year 2019-2020 for records expungement.
2. In February 2019, a subrecipient contract (No. 32001866) in the amount of \$50,000 funded through City General Funds from fiscal year 2018-19 was executed with Metropolitan Public Defenders (MPD) for the provision of services related to expungement pilot. The directive for this contract was Resolution No. 37368 passed in May 2018.
3. The purpose of cannabis tax allocation is same as the ongoing expungement pilot. Adding this allocation to the existing contract with appropriate amendments to scope, duration, budget and reporting can fund as many as 8 additional on-site expungement clinics at targeted locations to better serve community members, cannabis businesses or others affected by past cannabis policies and serve at least 150 additional participants.
4. The cannabis allocation is 200% of the original expungement contract and hence PHB requires City Council approval to increase the original contract amount and execute an amended contract.

NOW, THEREFORE, the Council directs:

- a. The Director of the Portland Housing Bureau is hereby authorized to amend the existing contract (No. 32001866) with MPD to increase compensation and extend duration, commensurate with the expanded scope of the program and reporting requirements, in substantial accordance with the amendment attached as Exhibit A.
- b. The Director of the Portland Housing Bureau is hereby authorized to sign amendments to modify the scope of the Agreement up to 25% of the modified contract amount.
- c. All other terms and conditions of Contract No. 32001866 between the City of Portland and MPD shall remain the same.


