

## **ORDINANCE No. 189730**

Amend the future street name of SW Northgate Ct to S Elysium Pl and amend the future street name of a portion of SW Buddington St to S Elysium Ave (Ordinance; amend Ordinance No. 188995)

The City of Portland ordains:

Section 1. The Council finds:

1. The Council adopted Ordinance No. 188995 on June 6, 2018 establishing the South Portland Addressing Area effective on May 1, 2020.
2. Residents of SW Northgate Avenue and SW Northgate Court have requested that the noncontiguous portions of the streets currently named as SW Northgate Avenue and SW Northgate Court be renamed to different street names to eliminate wayfinding confusion. PBOT has consulted with the Bureau of Emergency Communications, Bureau of Technology Services and the Bureau of Development Services on this proposed change, which will further the safety of the traveling public. An example of a preventable wayfinding accident is attached as Exhibit A.
3. Residents of SW Buddington Street concur with the renaming of the street to be an extension of S Elysium Avenue to eliminate wayfinding confusion; however, no properties are currently addressed as SW Buddington Street addresses. PBOT has consulted with the Bureau of Emergency Communications, Bureau of Technology Services and the Bureau of Development Services on this proposed change, which will further the safety of the traveling public. An example of a preventable wayfinding accident is attached as Exhibit A.
4. A map of the current SW Northgate Avenue, SW Northgate Court and SW Buddington Street is shown in Exhibit B, which also shows these streets' future names to be effective subsequent to Council passage of this Ordinance.
5. Exhibit C is attached to this Ordinance to provide an updated comprehensive list of street name changes to become effective May 1, 2020.
6. Exhibit D is attached to this Ordinance to provide an updated comprehensive list of address changes to become effective May 1, 2020, including address adjustments made by the Bureau of Development Services (BDS) for other streets whose names were amended by Ordinance No. 188995. BDS retains its authority to assign new addresses as appropriate and to correct any addresses subsequent to passage of this Ordinance.
7. The future South Portland Addressing boundary as shown in Exhibit H of Ordinance No. 188995 is not being amended by this Ordinance.

8. There are two parallel segments of SW View Point Terrace adjacent to SW Nebraska Street which are not being renamed by this Ordinance. The future South Portland Addressing boundary is not being amended by this Ordinance to follow the centerline of the more westerly segment of SW View Point Terrace.
9. There are two adjacent segments of SW Nebraska Street which are also not being renamed by this Ordinance. The portion of SW Nebraska Street west of the future South Portland Addressing Boundary as shown in Exhibit H of Ordinance No. 188995 shall remain as SW Nebraska Street, and the portion of SW Nebraska Street east of the future South Portland Addressing Boundary as shown in Exhibit H of Ordinance No. 188995 shall continue be renamed as South Nebraska Street effective May 1, 2020.


NOW, THEREFORE, the Council directs:

- a. The entirety of SW Northgate Court as shown in Exhibit B is renamed to South Elysium Place as of May 1, 2020.
- b. A portion of SW Buddington Street as shown in Exhibit B is renamed to South Elysium Avenue as of May 1, 2020.
- c. There is no change to the renaming of the existing SW Elysium Avenue to South Elysium Avenue as of May 1, 2020.
- d. There is no change to other portions of SW Buddington Street west of the future South Portland Addressing boundary as shown in Exhibit H of Ordinance No. 188995. Street segments of SW Buddington Street not shown in Exhibit B of this Ordinance will remain as part of Southwest Portland.
- e. The property currently addressed as 11355 SW Elysium Avenue will be readdressed as 11411 South Elysium Avenue as of May 1, 2020 in lieu of being readdressed to a South Buddington Street address as confirmed by BDS on August 21, 2019.
- f. The property currently addressed as 11407 SW Elysium Avenue will be readdressed as 11408 South Elysium Avenue as of May 1, 2020 in lieu of being readdressed to a South Buddington Street address as confirmed by BDS on August 21, 2019.
- g. The property currently addressed as 0936 SW Northgate Court will be readdressed as 11520 South Elysium Place as of May 1, 2020 in lieu of being readdressed to 11520 South Northgate Place; no change is being made to the address number assigned by BDS prior to the adoption of Ordinance No. 188995.

- h. The property currently addressed as 11605 SW Northgate Court will be readdressed as 11605 South Elysium Place as of May 1, 2020 in lieu of being readdressed to 11605 South Northgate Place; no change is being made to the address number assigned by BDS prior to the adoption of Ordinance No. 188995.
- i. Any street segment east of the future South Portland Addressing Boundary as shown in green in Exhibit H of Ordinance No. 188995 will have its street prefix changed from Southwest to South, including any new street segment or any street segment omitted from Exhibit C of this Ordinance.


