ORDINANCE No. 143281

An Ordinance authorizing the execution of an easement with Portland General Electric to enable Portland General Electric to relocate an overhead power line serving the Peninsula Drainage District No. 1 Pump in an area generally described as the center of the southern section of West Delta Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That Portland General Electric has requested an easement from the city to enable it to relocate its overhead power lines serving the Peninsula Drainage District No. 1 Main Pump Station, said easement is for an area generally described as the center of the southern section of West Delta Park.
- 2. That in granting this easement it will enable Portland General Electric to relocate the present power line which is obsolete and it will provide an easier opportunity to perform maintenance on the line.
- 3. The Commissioner in charge of the Park Bureau has approved the form of easement as attached to the original only hereof, marked Exhibit "A," and by this reference made a part hereof.

NOW, THEREFORE, the Council directs:

a. That the Mayor and the Commissioner of Public Affairs are hereby authorized and directed to execute and deliver an easement to Portland General Electric Co. for the construction and maintenance of overhead distribution lines through city-owned property which is generally in the center portion of the southern section of West Dela Park, substantially in accordance with the form of easement marked Exhibit "A," attached to the original only hereof and by this reference made a part hereof.

Section 2. The Council declares that an emergency exists because installation of the overhead electric service should be accomplished without undue delay and to assure continued power supply to Peninsula Drainage District No. 1 Main Pump Station, therefore, this ordinance shall be in force and effect from and after its passage by the Council.
