


EXHIBIT MAP FOR POWER LINE &

ORDINANCE No. 158327

An Ordinance authorizing the Mayor and Auditor to execute and deliver to Pacific Power and Light Company an easement to install and maintain an underground power line and power vault in Holladay Park, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Pacific Power and Light Company has a need to install a power vault and underground power lines in Holladay Park to service Tri-Met's light rail facilities on N.E. Holladay Street.
- 2. Pacific Power and Light Company has requested a 10-foot wide easement across Holladay Park for the power lines and vault (Exhibits "A", "B", and "C").
- 3. The grant of such an easement has been approved by the Bureau of Parks.
- 4. In compensation for the easement, PP&L has agreed to also create an underground vault and install a transformer the Park Bureau has in the park but is now above ground.
- 5. The easement for installation and maintenance of underground power lines and vault should now be executed.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are authorized to execute and deliver to Pacific Power & Light Company, 2126 N. Lewis, Portland, Oregon 97227, an easement to install and maintain underground power lines and vault through and in Holladay Park, said easement to be substantially in accordance with Exhibits "A", "B", and "C", attached hereto and by this reference made a part hereof.
- b. The Auditor is directed to return an executed copy of said easement to the Planning Section, Bureau of Parks.
- Section 2. The Council declares that an emergency exists because a delay in the grant of the easement would result in a possible delay in completing the Holladay Park light rail station; therefore, this Ordinance shall be in effect from and after its passage by the Council.
