### Purpose of proposed legislation and background information:

 Initiates local improvement district formation proceedings and schedules an LID Formation Hearing as a prerequisite to beginning survey and design of the project.

### Financial and budgetary impacts:

- Costs for this project will be posted to PBOT Capital Project T00903, which is pending inclusion in PBOT's FY 19-20 budget and five-year CIP forecast.
- Match funding is being provided in a fixed amount of \$2 million each from Prosper Portland tax increment financing (TIF) funds and PBOT Transportation System Development Charge (TSDC) funds.
- Work will be within the scope of the grant agreement authorized by Ordinance No. 189669 on August 28, 2019.
- Individual assessments for residential properties range from \$17,289 to \$416,896.
- The level of confidence is Low.
- No change to staffing levels.
- 10% of the LID revenue (\$445,406) is to be added to the FY19-20 fiscal year budget; 20% of the LID revenue (\$890,812) is to be added to the FY20-21 fiscal year budget; and 70% of the LID revenue (\$3,117,841) is to be added to the FY21-22 fiscal year budget for total LID revenue of \$4,454,059.
- 100% of the Prosper Portland TIF revenue of \$2 million is to be added to the FY22 budget.
- 100% of the PBOT TSDC revenue of \$2 million is to be added to the FY22 budget.
- The valuation to assessment ratio is 2.6 to 1 which is above the minimum 2.0 to 1 ratio referenced in Code Chapter 17.08. The LID Administrator recommends that

Council accept this risk given the reward of 1,500 to 2,000 housing units anticipated with this LID, which will support our transit partner, Tri-Met with transit-oriented development.

The project is not currently in the 5-year CIP.

### Community impacts and community involvement:

- Property owner outreach has been ongoing since completion of the NE 97th Avenue Green Street LID in 2014 and has intensified since last year.
- Property owner meetings were held in July 2018 and in September 2019.
- The LID is being initiated by majority petition support.

# PROPOSED AMENDMENTS TO NE COUCH – DAVIS STREET LOCAL IMPROVEMENT DISTRICT (LID) RESOLUTION

### I. PROPOSED AMENDMENT TO RESOLUTION.

Prosper Portland confirmed Tax Increment Financing (TIF) funding on September 11, 2019 and the Portland Bureau of Transportation confirmed Transportation System Development Funding (TSDC) for this project on October 8, 2019. Therefore, it is requested that Council approve the second to last paragraph on Page 3 of the Resolution to the following:

BE IT FURTHER RESOLVED, that <u>Prosper Portland will provide \$2,000,000 in Tax Increment Financing (TIF) Funding from the Gateway Regional Center Urban Renewal Area which was approved by the <u>Prosper Portland Commission on September 11</u>, 2019 and PBOT will provide \$2,000,000 in Transportation System Development Charge (TSDC) funding <u>which was administratively approved on October 8</u>, 2019 and <u>will also provide</u> overhead funding of \$454,058.88 for total <u>PBOT</u> funding of \$2,454,058.88.</u>



### II. PROPOSED AMENDMENT TO EXHIBIT A.

The first attachment to this memorandum is a petition signed by the new owner of Tax Lot 7501 on October 14, 2019. Therefore, it is requested that Council approve the appendment of the first attachment to this memorandum to Exhibit A of the Resolution.
