The City of Portland Ordains:

Section1. The Council finds:

- 1. Exhibit 1, attached, includes all incremental changes to the City appropriation schedule as a result of the Fall Supplemental Budget Process.
- 2. A memorandum, attached as Exhibit 2, identifies programs, projects, or activities that require appropriation adjustment or transfer of appropriation within bureau and fund budgets.
- 3. Exhibit 3, attached, shows, for informational purposes, a reconciliation of changes to all funds.
- 4. Exhibit 4, attached, shows, for informational purposes, all requests materially affecting the General Fund.
- 5. Exhibit 5, attached, shows all position changes.

- a. The FY 2019-20 Appropriation Schedule is hereby amended by adjusting appropriations for certain expenditures in various funds as indicated by the increases and decreases presented in Exhibit 1; explanation of these changes is provided in the memorandum attached as Exhibit 2.
- b. The number of authorized positions in the FY 2019-20 Revised Budget is hereby amended as presented in Exhibit 5.
- c. The actions amending the FY 2019-20 Revised Budget contained in this ordinance are binding City policy.
- d. The City Budget Office to adjust FY 2020-21 Current Appropriation Level targets as outlined in Exhibit 2.

Section 2. The Council declares that an emergency exists in order that FY 2019-20 Fall budget adjustments are implemented without delay; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
