ORDINANCE No. 189741

*Authorize the Director of the Bureau of Environmental Services to sign a property deed for Property Line Adjustment 19-141810-PR at 9442 NE 13th Ave and 1313-1315 NE Gertz Rd to create a new parcel (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- On May 26, 2010, Portland City Council passed Ordinance #183819 to authorize agreements for the conveyance of properties under the Bureau of Environmental Services' (BES) Grey to Green Land Acquisition and Johnson Creek Willing Seller Programs.
- 2. Subsequently, the Bureau of Environmental Services purchased property in the East Columbia Neighborhood for wetland enhancement, increased flood storage and stormwater treatment to improve the overall health of the Columbia Slough at 9422 NE 13th (Property ID R171690) and 1313-1315 NE Gertz Road (Property ID R171693).
- 3. In order to assemble the properties as a natural area and pursue disposition of a house on one of the properties, BES applied for a Property Line Adjustment with the Bureau of Development Services, as per Title 33, Planning and Zoning 33.667. The adjustment was approved (19-141810-PR, Exhibit A attached hereto), and a new deed was produced, which is awaiting signature authority.

NOW, THEREFORE, the Council directs:

- a. The Director of the Bureau of Environmental Services is authorized to sign a property deed, in substantially the same form as Exhibit B attached hereto, for the purposes described in Section 1.
- Section 2. The Council declares that an emergency exists because deed filing paperwork must be recorded with Multnomah County by November 16, 2019. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
