ORDINANCE No. 189750

Amend Public Improvements Code to make requesting and participating in Bureau of Environmental Services administrative reviews more customer-friendly (Ordinance; amend Code Chapters 17.32 through 17.39)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) manages Portland's wastewater and stormwater infrastructure to protect public health and the environment.
- 2. Portland City Code (PCC) and administrative rules administered by BES provide an avenue for affected ratepayers and customers to pursue reconsideration by BES employees of many types of BES decisions through a bureau process known as administrative review.
- Portland City Code and administrative rules administered by BES provide an avenue for affected ratepayers and customers to pursue appeal to the City's Code Hearings Office (CHO) of many types of BES decisions after completing the BES administrative review process.
- 4. In an effort to make sure BES provides clear and consistent information to its customers, BES reviewed language in City Code and its administrative rules and identified sections to be updated to ensure that requesting and participating in the BES administrative review process and the City appeal process is predictable, consistent, and user-friendly for its customers.
- 5. Earlier this year, BES completed a public rulemaking process to update BES administrative rules to meet the goals described in paragraph 4 above.
- 6. The proposed revisions to PCC Title 17 contained in Exhibit A complement those adopted rule changes. The proposed changes include removing language regarding which decisions are or are not subject to administrative review and appeal so that there is not inconsistent language in Code and rule and so that this information can be conveniently found in one place. The proposed changes also include deleting language regarding appeals to the CHO and associated fees paid to BES where the language is not consistent with language in PCC Title 22 that specifies that requests for appeals to the CHO and appropriate fee(s) must be paid directly to the CHO. In addition, the proposed code changes make certain existing BES authority explicit and therefore more transparent (e.g., the bureau's authority to limit administrative review and appeal, which it only exercises in limited circumstances, as specified explicitly in its administrative rules). In addition, the proposed Code changes improve readability, fix grammatical errors and typos, and revise language to make Code language gender neutral. Explanations are provided in Exhibit B.
- 7. Although BES was not required to do so, BES put the proposed code changes out for 30 days of public comment in May and June of 2019 concurrent with the required public comment period for the since-adopted changes to BES administrative rules. No public comments on the proposed code or rule changes were submitted.

NOW, THEREFORE, the Council directs:

a. That PCC Chapters 17.32, 17.33, 17.34, 17.35, 17.36, 17.37, 17.38, and 17.39 be amended as shown in the attached Exhibit A.
