ORDINANCE NO. 151858

An Ordinance amending Title 3, Administration, of the Code of the City of Portland by adding a new chapter to establish the Office of Housing Policy, effective July 1, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- There is a need to centralize the responsibility for the development and implementation of the City's Housing Policy, to coordinate housing related activities among various City agencies and to provide a central referral point for public information related to housing matters.
- This need can best be served by the creation and staffing of a new organizational unit.
- 3. Title 3, Administration, needs to be amended to establish this new organizational unit.

NOW, THEREFORE, the Council directs:

a. Title 3, Administration, of the Code of the City of Portland is hereby amended by adding a new chapter to read as follows:

Chapter 3.38 OFFICE OF HOUSING POLICY

The Office of Housing Policy shall consist of a manager and such other subordinate employees as may be provided by the Council. The Office of Housing Policy shall be responsible for the development of an annual City-wide housing management program in conjunction with other City agencies; coordinate and monitor housing programs in other City agencies; assume primary responsibility for liaison activities with local, state and federal agencies on housing matters; provide staff support for a Housing Advisory Committee which shall include the Downtown Housing Advisory Committee; and shall serve as the central referral agency for public information related to housing.

Section 2. The effective date of this Code change is hereby established as July 1, 1981.

Section 3. The Council declares that an emergency exists because it is necessary that the Code change be effective July 1, 1981; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
