Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary grade of the Human Resources Systems Analyst classification, effective November 6, 2019.


NOW, THEREFORE, the Council directs:
