ORDINANCE No.

*Authorize a contract with the lowest responsible bidder for the SE 52nd and Woodstock Traffic Signal Replacement Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The traffic signal at SE 52nd and Woodstock has been identified as a strong candidate for replacement by PBOT's Signals and Streetlighting engineers.
- 2. The project scope includes replacing the traffic signal at SE 52nd and Woodstock, protecting left turning movements, ADA corner ramp upgrades, and intersection paving.
- 3. The project is identified in the City's Capital Improvement Program (CIP).
- 4. The Bureau of Transportation has funds budgeted in FY 2019/20 and 2020/21 for construction, inspection and management of the project.
- 5. The Bureau's level of confidence in the cost estimate for this project is moderate; project is well defined, and plans and specifications are nearing completion.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Office is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00749 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because the project must be bid as soon as possible to begin construction in 2019; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
