

ORDINANCE No. 189779

Accept a FY 2019 State Homeland Security Program grant in the amount of \$31,157 from the Oregon Department of Emergency Management to enhance emergency preparedness by providing emergency equipment to assist vulnerable Portlanders in the event of a disaster (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:


1. The Oregon Department of Emergency Management provides financial assistance to selected municipalities through the Fiscal Year (FY) 2019 SHSP grant. The SHSP will provide neighborhood disaster response equipment caches and evacuation chairs in Home Forward buildings.
2. The City of Portland is accepting financial assistance to support emergency preparedness needs for Portland residents.
3. There is no match requirement for this grant.

NOW THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland, a State Homeland Security Program grant from the Oregon Department of Emergency Management in the amount of \$31,157 and to execute the grant agreement.
- b. The Office of Management and Finance (OMF) Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- c. The Director of the Portland Bureau of Emergency Management (PBEM) is authorized to accept on behalf of the City of Portland any subsequent modifications by the Oregon Office of Emergency Management for the FY 2019 SHSP, grant number 19-257, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by Council.
- d. The Director of the Portland Bureau of Emergency Management is authorized to execute related subrecipient grant awards, contracts and amendments.


