

ORDINANCE No. 189793

*Authorize the Transportation Director to sign an agreement with the Union Pacific Railroad Company for construction services for the Earl Blumenauer Bicycle and Pedestrian Bridge (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Transportation is constructing the Earl Blumenauer Bicycle and Pedestrian Bridge across the Union Pacific RR tracks in the Sullivan's Gulch.
2. The Union Pacific RR will need to provide rail flagging services for construction of the project in UPRR right of way.
3. The Union Pacific RR will grant an easement to the City of Portland for the purposes of the project.
4. The Bureau's level of confidence in the cost estimates for this project is high as it is based on the estimate from the RR.

NOW, THEREFORE, the Council directs:

- a. That the Director of Transportation is hereby authorized to enter into a contract with the Union Pacific RR in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because rail flagging will be necessary for project construction therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
