- "A-1 Line" on easement S.W. 57th Avenue 475 ft. + north of Skyline. ("A-1 Line" is 126 ft. + long.)
- "A-2 Line" on S.W. Mill St. easement and S.W. 57th Avenue 813 ft. + north of Skyline. ("A-2 Line" is 275 ft. + long.)
- "B-Line" on easement between S.W. 57th and 58th Avenues from S.W. Skyline Blvd. to 58th Avenue and S.W. 58th Avenue from S.W. Salmon St. southerly 193 ft. <u>+</u> and S.W. Salmon St. from 58th Avenue northeasterly 446 ft. <u>+</u>. ("B-Line" is 2,130 ft. <u>+</u> long.)
- "B-1 Line" on easement and S.W. 58th Avenue from S.W. Clay St. 625 ft. <u>+</u> northerly. ("B-1 Line" is 800 ft. <u>+</u> long.)

ORDINANCE No. 138613

An Ordinance accepting sewer easements and a bill of sale for sewers in Sylvan Heights Service District No. 4 of Multnomah County.

The City of Portland does ordain as follows:

Section 1. The Council finds that on September 2, 1971 an agreement was executed between the City and the Sylvan Heights Service District for the use of City sewage facilities; that said agreement provides that after completion of construction of the sewers in the area covered by the Agreement the District shall turn over the sewer lines to the City with a bill of sale; that all severs to be covered by the bill of sale have now been constructed; that the Board of County Commissioners for Multnomah County, Oregon, Acting as the governing body of Sylvan Heights Service District No. 4 on November 29, 1973 ordered the execution of the Bill of Sale and on February 28, 1974 ordered the execution of the Assignment of the sewer easements to the City of Portland; that such executed original bill of sale and copy of the assignment of easements are attached to the original of this ordinance; that it is the recommendation of the Commissioner of Public Works that the City accept the Bill of Sale and Assignment of Easements; now, therefore, the Bill of Sale and the Assignment of Easements for sewers described herein are hereby accepted.

Section 2. That the City Auditor be and he is hereby directed to have the Assignment of Easements, as described in Section 1 of this ordinance, and the Bill of Sale for the sewers, as also described in Section 1 of this ordinance, placed on record, and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in making this assignment of easements and Bill of Sale a matter of record; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
