ORDINANCE No. 141182

An Ordinance authorizing extension of contract with Northwest District Association, the community association of Northwest Portland, Inc., Northwest Industrial Neighborhood Association, Inc., and Citizens for Hillside Recreational & Community Center, Inc. for the operation of the Neighborhoods West-Northwest office for the period February 1, 1976 through June 30, 1976, transferring \$10,442 from the Office of Neighborhood Associations, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City entered into contract #14959 with Northwest District Association, the community association of Northwest Portland, Inc. (hereinafter N.W.D.A.), the Northwest Industrial Neighborhood Association, Inc. (hereinafter N.I.N.A.), and Citizens for Hillside Recreational & Community Center, Inc. (hereinafter Citizens for Hillside), for the operation of the Neighborhoods West-Northwest office, the contract term was July 1, 1975 through December 31, 1975 and was later extended through January 31, 1976. The contract price was \$12,290.
- 2. The contract can be extended through June 30, 1976 utilizing \$10,442 authorized in the budget of the Office of Neighborhood Associations for the contract.
- 3. The contract budget should be amended to authorize expenditure of these funds according to Exhibit A attached hereto.

NOW THEREFORE, the Council directs:

- A. Contract #14959 shall be extended through June 30, 1976 upon N.W.D.A., N.I.N.A., and Citizens for Hillside filing with the City Auditor an acceptance of the terms of this ordinance.
- B. The budget for contract #14959 is amended as provided for in Exhibit A hereof, transferring \$10,442 from the budget of the Office of Neighborhood Associations, and authorizing the Mayor and the City Auditor to draw and deliver warrants addressed to Neighborhoods West-Northwest, 817 N.W. 23rd, City 97210.
