ORDINANCE No. 138201

An Ordinance accepting an easement for a drain line at 6304 S. W. Canby Street from Elizabeth C. Bancroft and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that it is necessary and desirable in connection with more efficient water service that an easement for a drain line at 6304 S. W. Canby Street from Elizabeth C. Bancroft be accepted by the City; drain line to serve a Water Bureau meter vault in S. W. 62nd Place and Multnomah Boulevard, and that acceptance of said easement has been recommended by the Chief Engineer of the Bureau of Water Works and approved by the Commissioner in charge of said Bureau; now, therefore, acceptance of an easement for said drain line from Elizabeth C. Bancroft hereby is authorized, said easement being more particularly described in EXHIBIT A, attached to the original only of this ordinance and by this reference made a part hereof.

Section 2. Upon acceptance of said easement by the City, the City Auditor shall place said easement of record with the County in which it is located. The Mayor and the Auditor hereby are authorized to draw and deliver a warrant in the amount of \$100.00 chargeable to the Water Fund (184.730) Budget (Page 234, line 2) Improvements Other than Buildings (BUC 18400031) R/E Code 433, when demand is presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the needed easement, as set forth in Section 1 hereof, may be accepted without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
