

## 141885

An Ordinance amending Chapter 3.02, Council Organization and Procedure, of the Code of the City of Portland by changing the time by which documents must be on file in the Office of the City Auditor to be entered on the calendar of the council proceedings for the following week, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the Code of the City of Portland as presently written requires that a summary of all matters to come before the Council at the next regular session must be prepared by the City Auditor for public use and for the Council.
2. That all documents to be entered on the Council Calendar for the next regular session must be on file in the Office of the City Auditor before two p.m. on each Friday preceeding the council meeting.
3. That this two p.m. deadline for the filing of council documents does not allow sufficient time for the proper processing of these documents and the preparation of the calendar for submission to the printer.
4. That the City Code should be amended to provide for an earlier deadline for the submission of council documents to the Office of the City Auditor to be filed for the next regular council meeting.

NOW, THEREFORE, the Council directs:

- a. That Chapter 3.02, Council Organization and Procedure, of the Code of the City of Portland is amended as follows:

3.02.030 Entry of documents on calendar. The city auditor shall cause to be printed for public use and for the council, twenty-four hours before each session, a summary of all matters to come before the council at the next regular session. The summary shall be known as the official calendar of the council proceedings. No document shall be entered on the calendar which is not on file in the office of the city auditor before 10 a.m. each Friday preceeding the council meeting.
