## ORDINANCE NO. 155112

. .

An Ordinance vacating the westerly 26.09 feet of NE 2nd Avenue lying between the south line of NE Davis Street and the south line of NE Everett Street, under certain conditions.

The City of Portland ordains:

Section 1. The Council finds:

- By Resolution No. 33496, adopted by the Council July 13, 1983, proceedings were initiated for the vacation of the westerly 26.09 feet of NE 2nd Avenue lying between the south line of NE Davis Street and the south line of NE Everett Street.
- The purpose of the vacation is to consolidate property for future development.
- The vacation is recommended by the Commissioner of Public Works, subject to certain conditions set forth in the directive action below.
- 4. In accordance with ORS 271.100, the Council fixed a time and place for public hearing before the Council; the Auditor published notice thereo; and posted notice in the area proposed to be vacated.
- 5. Other procedural requirements of ORS 271 have complied with and the Council having held a public hearing finds no objections were made or filed thereto and it is in the public interest that said street area be vacated.

NOW, THEREFORE, the Council directs:

a. That the following described street area is hereby vacated:

R/W #3622

The westerly 26.09 feet of NE 2nd Avenue lying between the south line of NE Davis Street and the south line of NE Everett Street.

- b. The vacation of the above described street area is granted, subject to the following conditions and restrictions:
  - Nothing herein contained shall cause or require the removal or abandonment of any sewer, water or gas main, conduit of any kind, wire, pole or thing used, or intended to be used, for any public service, and the right hereby is reserved for the owner of any such utility or thing to maintain, continue, repair, reconstruct, renew, replace,
