An Ordinance authorizing a request to revise Grant No. 07-51-03292 from the Economic Development Administration for construction of tennis courts in Gabriel Park, and declaring an emergency.

The City of Portland ordains:

ORDINANCE No. 144310

Section 1. The Council finds:

- 1. The City has been awarded an EDA grant of \$325,522 for construction of eight outdoor tennis courts at Gabriel Park.
- 2. Construction of four courts is now under way but neighborhood sentiment led to denial of a conditional use permit for the final four courts.
- EDA has expressed willingness to accept a request to move construction of four courts to another suitable site in the project area (Southwest Portland).
- 4. On August 22, 1977, the Portland School Board approved agenda item 3482 directing its "administrative staff to proceed with negotiations with the City of Portland to permit construction of four outdoor courts at Andrew Jackson High School."
- 5. The Bureau of Parks and Recreation and the Commissioner in charge recommend movement of the remaining four courts to be built from Gabriel Park to Jackson High School as in the best interest of the citizens of Portland.
- It is estimated that no additional cost will accrue to EDA or the City of Portland.

NOW, THEREFORE, the Council directs:

alendar No.

- a. The Mayor and the Commissioner in charge shall make a request to EDA to move the construction site of four outdoor tennis courts from Gabriel Park to Jackson High School.
- The Commissioner in charge is authorized to provide such information as required for processing the request.

Section 2. The Council declares that an emergency exists because delay in a request for modification may result in loss of grant revenues and cancellation of the project; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
