## ORDINANCE No. 156673

An Ordinance declaring Fire Station No 27 and the real property at 11212 NW St. Helens Road surplus, authorizing the Bureau of Facilities Management to negotiate a sale of the property, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 1-104 of the City Charter authorizes the City to sell real property not needed for public use by negotiation, bid, auction, or any other method the Council finds appropriate.
- 2. The real property at 11212 NW St. Helens Road and the improvements thereon (Fire Station No. 27) are surplus to the needs of the Fire Bureau.
- It is in the City's interest to advertise the property for sale to the general public thereby exposing the property to the maximum number of potential purchasers.

NOW, THEREFORE, the Council directs:

- a. The real property and the improvements thereon located at 11212 NW St. Helens Road hereby is declared surplus.
- b. The Bureau of Facilities Management is authorized to negotiate a sale of the real property.

Section 2. The Council declares that an emergency exists since a delay in the sale of the subject property will result in a loss of revenue to the City of Portland; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
