Legislation title: Award a Price Agreement to Rapid Response Bio Cleaning, LLC. for campsite cleanup services for \$4,528,000 annually, over a five-year period (Procurement Report - RFP No. 00001288)

Purpose of proposed legislation and background information:

The purpose of this legislation is to authorize a Price Agreement for campsite cleanup services, and to provide payment for the services.

Financial and budgetary impacts:

The cost of the campsite cleanup services will be funded over the five-year period with annual appropriation in the OMF-HUCIRP budget and an intergovernmental agreement with the Oregon Department of Transportation (ODOT) for campsite cleanup and personal property storage on ODOT properties within the City of Portland (IGA No. 33263).

Community impacts and community involvement:

There are considerable positive impacts on the community by allowing the City to reduce the impacts of unsanctioned camping via consistent and humane management of public spaces within the city of Portland, Oregon.

In FY 17-18, the City's Homelessness and Urban Camping Impact Reduction Program (HUCIRP) managed the work to clean 3,122 campsites on City properties; removing 8,400 gallons of human waste, 1,300 tons of garbage, and in partnership with Clean Start, removed 28,909 improperly discarded hypodermic syringes.

Crews are tasked with performing cleanup activities in accordance with complex legal guidelines, often in unfavorable weather conditions, and in a way that, to the greatest extent possible, resists further traumatization of those effected by these cleanups. To effectively and humanely address the complex and competing needs of all community members, contracted crews are trained on the following: policies and procedures on posting and cleaning campsites in accordance with the Anderson Agreement, as well as the collection and storage of personal property. To best support community members living unsheltered, crews are also trained in the use of Naloxone, assertive engagement, de-escalation, and communication with individuals in crisis.

The scope of services provided under the Price Agreement includes tasks such as the removal of temporary structures, garbage and biohazards in the rights-of-way, coordinating with social service providers, emergency medical providers, law enforcement, and other community stakeholders to address the needs of persons living unsheltered at the camp sites. This may require the contractor to make an assessment and adjust their operations to ensure a person receives medical care on site, and coordinate with social service providers to facilitate service access appointments, and to respond quickly to law

enforcement requests when conditions at a campsite pose a threat to health and human safety to the community.

The City of Portland coordinates weekly with social service providers, including reporting specific camp locations posted and scheduled for cleanup to social service providers up to a week before camps are cleaned. The contractor shall post in accordance with cleanup guidelines and communicate these postings to social service providers and community stakeholders immediately. As individuals experiencing homelessness are forced to move from location to location, this communication and coordination is critical, as it can be challenging for social service providers who are attempting to connect them to important services to locate them when housing, medical, and mental health services become available.

Over 140 State of Oregon COBID certified firms were solicited. A pre-proposal meeting was held at the Oregon Association of Minority Entrepreneurs (OAME), and a second meeting was held to increase the number of eligible proposers. The City intends to further engage COBID firms to provide insight on the goals of the HUCIRP, and gauge the education and training needed to prepare and develop smaller firms to successfully meet the high expectations of this work, with the goal of introducing them to the project in the capacity as an auxiliary to the principal contractor.

A participant from the Minority Evaluator Program was a scoring member of the Evaluation Committee.
