

**ORDINANCE No. 189844**

\*Amend contract with MEI-Charlton for \$32,371 for Special Inspections and Material Testing for the 10<sup>th</sup> and Yamhill SmartPark Garage Renovation Project (Ordinance; amend Contract No. 30006301)

The City of Portland ordains:

Section 1. The Council finds:

1. On April 1, 2018 the Chief Procurement Officer entered into Contract No. 30006301 with MEI-Charlton, Inc, for \$100,000.
2. The purpose of the contract is to provide Special Inspections and Material Testing services for the 10<sup>th</sup> and Yamhill SmartPark garage renovation project.
3. The project is under construction and Final Completion is anticipated in May 2020. Additional services are required by MEI-Charlton to achieve Final Completion.
4. The contract amendment exceeds 25% of the original contract value and therefore Council approval is required.


NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge is hereby authorized to amend the contract with MEI-Charlton in a form similar to the amendment attached as Exhibit A.

Section 2. The Council declares that an emergency exists because construction is ongoing, and special inspections and materials testing is required throughout construction activities; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.

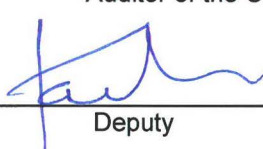
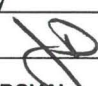

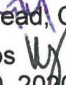
