Receipt is acknowledged of your telegram of November 13, 1920, relative to the case of a Chinaman suffering from leprosy in your locality.

The Government has, at the present time, no available facilities for handling this class of cases. Plans are under way for the acquiring of a Government sanatarium for the care of these patients, but, as yet, the matter has not been entirely settled, and until such time as this is consummated, no action can be taken by this Bureau.

It is suggested, however, that a full history of the case be forwarded to this Bureau, with particular emphasis on the length of time he has been in this country; also the length of time symptoms of the disease have been present.

You will be advised as soon as available space is to be had at the Government institution, and the transfer can be made at that time if proper to be done.
