## Carpenter, - Meat Cutter.

Many persons reported that Carpenter sold a lot of meat on the market. Some of them complained that he did not give all the meat when he cut for them. back. / All claimed that Carpenter had no stock of his own.

Mrs. Lois Shanks says positively that he sold as high as 20 fuscles well and other meet hogs in one year, or more, That she sold for him. Sold 2 hogs and veal one keef on one Saturday besides selling for other persons.

## Eastman's Conquest.

A number of persons told us about Mr. Eastman's conduct with one Ruby Alexander. Mrs. Shanks says that before she knew the woman, Eastman wanted her to board her at her home, but she refused.

Mr. Wright, the Assistant Market Master first told us about This woman. Then Mrs Eaton, Mrs. Shanks and others went into the matter and told the whole story. It is generally known on the market.

## Buying and Selling

It was reported to us that most persons selling on the market were selling for others. Had nothing of their own. And most of them were selling on commission.

Tourney, Eastman's cousin, sold cold storage eggs on the market without marking them. Candled them in room on east side of 4th street, near Taylor, in back room of cleaning establishment.

Mrs. Lois Shank, Mrs Eaton, Fred Hoffman, Wm. McCowan 561 East 46th St North and others. Few of the Italians but what are buying; Nobody knows what the Japs and Chinese are doing. It was reported that one Jap paid for all the stalls and parceled them out as he saw fit. This matter not fully corroborated.
