#### Pam Knowles – Biography

Pam Knowles is Oregon native and Portland businesswoman with more than 40 years of professional experience. She is currently the Principal of Pam Knowles Consulting and assists businesses (non-profit and for-profit) with organizational development, executive coaching and strategic planning. Most recently she served as the Executive Director for Industry Relations for the College of Business at Oregon State University. Previously she was a partner in the law firm Davis Wright Tremaine for over 15

years, where she focused on business organization, employment, hospitality and education issues. She was also the Chief Operating Officer and General Counsel for the Portland Business Alliance, the Director of Marketing and Development for Portland Center Stage, and the Executive Director for the Oregon Commission on Judicial Fitness and Disability.

Ms. Knowles was elected to the Portland Public Schools Board of Directors and served from 2009-2017. She served four years as the co-chair of the Board. She currently serves on the Willamette Falls Trust Board, the Center for Women's Leadership Board and the board of Friends of Baseball. Other volunteer activities have included the Portland Business Alliance Charitable Institute, Nike School Innovation Fund, Oregon State Alumni Association, Regional Arts and Culture Council, Oregon Women Lawyers, the State of Oregon Commission on Childcare and the Chalkboard Advisory Council.

Ms. Knowles is a Senior Fellow of the American Leadership Forum. In 2011, Ms. Knowles was selected as a Woman of Influence by the Portland Business Journal. In 2015, she was awarded a Newcomb Fellowship by the College of Business at OSU, and in 2016 was selected for the "Scram Graham" Leadership Award by the OSU Alumni Association.

## Sho Dozono – Biography

Sho Dozono is businessman and politician from Portland, Oregon. He was a nominee in the 2008 Portland mayoral race. A prominent member of the Portland business community, Dozono served as chairman of the chamber of commerce, and he has been the CEO and owner of the regional travel agency Azumano Travel since 1987. He ran for public office on a platform centering on fiscal responsibility and his history of civic and educational activism.

Dozono has a long history of participating in community and business activities in Portland and serving on organizational boards. In 1996, he organized a 30,000-person march in support of funding for the Portland Public Schools. He was



one of the founders of the Portland Schools Foundation, a private fundraising organization.

Following the September 11, 2001 attacks, Dozono organized the "Flight for Freedom", a group of Oregonians who flew to New York City to support the city's tourist economy, in response to a plea by Mayor Rudy Giuliani. Similar "Flight of Friendship" trips were organized to Thailand following the 2004 tsunami and to New Orleans in the wake of Hurricane Katrina. In 2002, Dozono was instrumental in bringing the Olympic Torch to Portland. Dozono has served as a City of Portland Community Budget Advisor since March 2017.

#### Personal Statement

Sho Dozono was born in Japan and his family moved to Portland when he was 10. He attended Cleveland High School and received a B.A. in education and history from the University of Washington. He served in the US Army after receiving a master's degree at Portland State University and then began his teaching career at Grant High School.

In 1976, Dozono joined his father-in-law's business, Azumano Travel. He became president in 1981 and owner in 1987. Azumano has 215 agents in three states and holds several large corporate and government travel contracts. He has since retired but is still active in the community, serving as co-chair for the City's New Portland Foundation. He is currently serving his second term as a Trustee at Portland State University. Dozono and his wife have five children.
