TO THE COUNCIL:

Council approved Ordinance 189788 on December 04, 2020 for Procurement Services to competitively solicit the Creston Park Playground Improvements Project in accordance with PCC 5.34. The Chief Procurement Officer has advertised and received bids for Bid Number 00001394 on behalf of the Portland Parks & Recreation (PP&R) with a project construction estimate of \$1,500,000.00. PP&R rated the project estimate confidence level as medium.

Bids were opened on February 04, 2020, and Four (4) bids were received. The lowest responsive bid is from Faison Construction, Inc. Thus, Procurement Services recommends that Council accept this Report and authorize the Chief Procurement Officer to execute the contract with Faison Construction, Inc. in the amount of \$1,332,810.00.

PP&R and Procurement Services identified an aspirational goal for COBID Certified subcontractor and supplier utilization at 20% of the hard construction costs for the project. Below is the utilization plan:

- 48.67% Self-performed by Faison Construction Inc.
- 9.34% Certified COBID subcontractors
- 41.99% Non-Certified subcontractors
