

RESOLUTION No. 37484

Appoint Adam Green, Megan Bigelow, Carol Johnson, Taylor Snell, Shaina Pomerantz and reappoint Andrea Chiller to the Citizen Review Committee, an advisory board to the City Auditor’s Independent Police Review and the Police Bureau’s Internal Affairs. (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Citizen Review Committee;

WHEREAS, an eleven-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review and Internal Affairs;

WHEREAS, the committee has five vacancies resulting from the resignation of three members and from completion of terms by two members;

WHEREAS, a Selection Committee consisting of three Citizen Review Committee representatives, two members of the community, and two staff members from Independent Police Review reviewed applications. A panel of one Citizen Review Committee member and two Independent Police Review staff members interviewed 10 candidates. They recommended six to the City Auditor for nomination for Council appointment

WHEREAS, the City Auditor has nominated six candidates to City Council, including one who is put forth as an alternate should there be any member resignations within the term;

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon, appoints to the Citizen Review Committee new members Adam Green, Megan Bigelow, Carol Johnson, Taylor Snell, and Shaina Pomerantz, and reappoints Andrea Chiller for a three-year term. Active members’ terms will begin March 18, 2020, and end March 17, 2023. The alternate member’s term will begin when they are seated on the committee.
